

OMG 2019 Militaria Market Regulations

Set up the stalls

It is possible to set up the sales stall starting on Friday, September 13, 2019, at 8:00 am. On all following days, it is permitted to unload merchandise with vehicles only before 8:00 am, provided that the organization of the market is not disturbed. Further on the day, this is only permitted with pushed trailers or other hand-driven carts. Placing your vehicle at the market stall is possible. You must take care of any electricity at the fair or place to sleep yourself.

Overnight

After you have arranged your stall, it is possible to stay overnight on or near the Militaria market. No provisions have been made for this, and you must bring all the materials you need for the overnight stay yourself. If you can not do it yourself; there usually are colleagues who stay overnight on the premises. Leaving an equipped stall is entirely at your own risk. You must organize any insurance yourself. The organization of OMG2019 is in no way liable.

Opening and closing

You can open stall according to your insights, from the start of the event on September 14, 2019. On departure, however, the marketplace must be left empty and clean by the end of the event on Saturday 21 September 2019 17:00.

Parking transport vehicles

After unloading your merchandise from your vehicle, it must be parked behind the market area at the instructions of the market committee or employees. A parking space has been set up for this.

Garbage

Please keep a trash bag in your stall; this is for all the garbage that you produce during the day. It is the intention that you take this full garbage bag and throw it away at home.

Car boot sales

The car boot salesmen are guided to their place by an employee. All payments are made in advance with the coordinator, and you will have access to a designated location.

Wristbands

Two employees per market stall and one per boot sale or vehicle sale will receive a wristband. The other sales employees must pay admission costs at the Militaria market coordinator.

General

Neither the management nor employees of the OMG2019 foundation can be held liable for accidents, theft, disappearance or any damage to property of third parties. The market committee has the right, without giving reasons, to allocate or deny the market stalls you have reserved. By confirming your registration, you declare that you agree with this.



IN ALL CASES WHERE THE MILITARY MARKET REGULATION DOES NOT PROVIDE THE MARKET COMMITTEE CAN DECIDE ON THE SPOT.

The board of the OMG2019 foundation reserves the right to cancel the Militaria market entirely or partially if there are too few registrations. You will receive timely notice of this.

Selling on the ground is equal to tent sales costs.

Reservations

It is possible to reserve one or more stalls until 1 September 2019.

Note: if you respond early you have a chance of winning the best place (s)!

After that, it is only possible to apply for trunk/trailer sales (no car at the sales location) or on the overflow sites outside, which are allocated in the order of arrival on the exhibition days themselves.

Payment

The payment must be received ten days before the start of the exhibition on account of OMG with mention of Militaria fair.
